Important - Upgrade from Eikon to Refinitiv Workspace

To ensure our customers gain more value from our new platform, we encourage each customer to upgrade their current Refinitiv Eikon Variant(s) to the corresponding Refinitiv Workspace Variant(s) (as set out below).

Your Agreement - Key Changes

Refinitiv Workspace Variant(s) constitute an upgrade to your Refinitiv Eikon Variant(s) and will remain subject to the terms and conditions of your existing order form(s), underlying agreement and any supplemental documents thereto comprising your contractual framework (the "Agreement"). Accordingly, there is no need to sign any additional order forms in connection with the upgrade. However, as your Agreement is based on legacy terms for the Refinitiv Eikon Variant(s), the contract



variations set out in Exhibit A will apply to your use of Refinitiv Workspace Variant(s) and will become binding terms of the Agreement from the date of upgrade ("Workspace Amendments"). Capitalised terms used but not defined herein shall have the meanings given to them in the Agreement. In the event of any conflict between the terms of the Agreement and the terms of this letter, the terms in this letter shall prevail.

We hope you enjoy using Refinitiv Workspace, which is a faster, easier-to-use and highly customizable service. Please be assured there will be no immediate increase to your total monthly fees for the Refinitiv Eikon Variant(s) and applicable add-ons resulting exclusively from this upgrade. As a result of the more enhanced nature of Refinitiv Workspace, we may increase the fees in future to reflect the improved service which will remain in line with the terms of your Agreement, and we will continue to work with you to ensure that our services offer high performance and excellent value. Your invoice may, however, look different to reflect the new product name and any necessary changes to your licensing structure which will become apparent during the upgrade process. In particular, as we will be simplifying how Reuters Domestic News is commercialized, Reuters Domestic News will no longer be a separately charged item on your invoice. Going forward, Reuters Domestic News will be integrated within your Refinitiv Workspace Variant(s); accordingly, your invoice will show a consolidated fee which will reflect the price you have been paying for the relevant Refinitiv Eikon Variant(s) and the associated Reuters Domestic News.

Additionally, following migration from a relevant Eikon variant to the corresponding Refinitiv Workspace and Refinitiv Workspace Add-On, your invoice will be updated to show the new licensing structure, as represented in the below table.

Your total monthly fees for the relevant Eikon Variant will be split across the corresponding Refinitiv Workspace and the Refinitiv Workspace Add-On. Where the Refinitiv Workspace Add-On is presented on your invoice as a zero-rated charge this is due to our pricing structure change resulting from the upgrade and the value is reflected in the billing for Refinitiv Workspace.
